Village of Fonda Park Vendor Rules



Vendor Registration: All vendors must register with the Village of Fonda authorities before participating in any Recreational & Canalside Park event.

Compliance with Laws: Vendors must comply with all federal, state, and local laws, including health regulations, permits, sales tax permits, and licenses required for product sales, food handling, and preparation.

Insurance Requirements: Vendors are required to carry liability insurance and provide proof of coverage to the Village of Fonda authorities. The Village of Fonda must be added as additional insured on all certificates.

A "Hold Harmless Agreement must be signed upon registration for approval of the registration.

Set-Up and Breakdown: Vendors must adhere to designated set-up and breakdown times provided by event organizers. Set-up areas must be kept clean and free of debris at all times.

Product Display: Vendors are responsible for their products' safe and attractive display. All items must be clearly priced and labeled. The sale of knock-off products is strictly prohibited.

Vendors are strictly prohibited from selling adult, smoking, and other dangerous materials. This includes, but is not limited to, pornography, explicit literature, tobacco products, vaping devices, and other items deemed hazardous or inappropriate for a family-friendly environment.

Noise Levels: Vendors must ensure that any amplified sound or noise generated from their booth does not disrupt the enjoyment of the park by other attendees.

Trash Disposal: Vendors are responsible for the proper disposal of all trash generated from their booths. The Village of Fonda provides trash receptacles for patrons, and they must be used for this purpose.

Smoking Policy: Smoking is prohibited within designated Recreational & Canalside Park areas. Vendors and their staff must comply with this policy at all times.

Alcohol Sales: Vendors are prohibited from selling alcoholic beverages unless explicitly authorized by event organizers and in compliance with local alcohol regulations.

Compliance with Event Organizers: Vendors must comply with any additional rules or directives provided by event organizers or Village of Fonda authorities.

Parking: Vendors must park their vehicles in designated parking areas and refrain from blocking access roads or parking spaces designated for event attendees.

Cooperation with Authorities: Vendors must cooperate with Village of Fonda authorities and event organizers to ensure the smooth operation of Recreational & Canalside Park events.
